PAYMENT OF BASE COMPONENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN MANULIFE US REAL ESTATE INVESTMENT TRUST (“MANULIFE US REIT”)

Manulife US Real Estate Management Pte. Ltd., as manager of Manulife US Real Estate Investment Trust (the “**Manager**”), wishes to announce that a total of 1,908,367 Units in Manulife US REIT (“**Management Fee Units**”) have been issued on 27 August 2018 at an issue price of US\$0.8648 per Unit to Manufacturers Life Reinsurance Limited (“**MLRL**”), an entity nominated by the Manager to receive the Management Fee Units in its place¹.

The Management Fee Units have been issued as payment of 100% of the Manager’s base fee (“**Base Fee**”) for the period from 1 April 2018 to 30 June 2018 (both dates inclusive) (“**2Q2018**”).

The Base Fee is calculated in accordance with the trust deed constituting Manulife US REIT dated 27 March 2015 (as amended and restated) (the “**Trust Deed**”). In accordance with the Trust Deed, the Manager may elect to receive the Base Fee in the form of cash and/or Units, in such proportion as may be determined by the Manager. The Manager has elected to receive 100% of the Base Fee for 2Q 2018 in the form of Units.

The issue price of the Management Fee Units is based on the volume weighted average price for a Unit for all trades on Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) in the ordinary course of trading on the SGX-ST for the last 10 business days immediately preceding (and for the avoidance of doubt, including) 30 June 2018. Following this issuance, the Manager holds 6,525,802 Units. The total number of Units in issue as at 27 August 2018 is 1,272,689,270.

¹ The Manager has sold the Management Fee Units which it is entitled to receive as payment of the Base Fee to MLRL, a wholly-owned subsidiary of The Manufacturers Life Insurance Company, and in connection with the sale, the Manager has directed that such Management Fee Units be issued directly to MLRL instead of the Manager.
